Hopeweavers Statement on domestic abuse & viole

Introduction

Domestic violence and abuse can take many forms. For some people it means living with constant threats or being belittled, constantly criticised or humiliated For others it can involve physical and sexual abuse and being financially abused. Controlling behaviour by the abuser seeks to make the victim subordinate, depriving them of the means of independence. Domestic abuse and violence includes so-called 'honour' based violence, female genital mutilation (FGM) and forced marriage.

Victims are not confined to one gender or ethnic group although women and girls are disproportionately victimised. Domestic violence and abuse in any form will always be emotionally devastating for children.

How might Hopeweavers encounter people affected by domestic abuse?

In providing sanctuary space we welcome everyone, of any faith or none, regardless of their background and personal characteristics (e.g. age, disability, gender, racial heritage, sexual orientation or identity). A person attending a sanctuary space event may disclose that they are suffering or have suffered domestic abuse. A disclosure could also be made by a Member or Enquirer of the Community in another type of Hopeweavers meeting (e.g. Members' group).

Principles

Domestic violence and abuse is **never** acceptable. We are opposed to all forms of domestic abuse. Our stated values are: Christian love and acceptance of others, hospitality, simplicity, compassion, listening, sharing, sanctuary, creativity and encouragement. We aspire in our activities to value, listen to and respect both survivors and alleged or known perpetrators of domestic abuse.

When a concern is raised

Every person will have their own unique story and circumstances, however if there is immediate danger, the police should be called on 999, otherwise, it is our intention that we should:

- Listen respectfully to the person, responding appropriately to their wishes and situation, recognising that we are not a specialist in this area, but can signpost to others who are.
- Treat the matter in confidence, seeking the person's permission to involve other people as appropriate, however there are some circumstances when others must be informed, i.e. when there are concerns involving children or vulnerable adults being at risk of abuse, or if the person is at risk of serious injury or death. Contact details are at the end of this statement.
- Encourage the person to seek help from a specialist organisation, their own GP, or another trusted source with expertise in this area.

Steps we will take to support those affected by domestic abuse

- 1. Leaders of Sanctuary Space events, Enquirer Guides, Members' group leaders and Hilfield House Hosts are all required to undertake Basic and Foundational Safeguarding training provided by the Church of England. This covers basic information as to how to recognise various types of abuse and to respond appropriately.
- 2. Guardians and the Designated Safeguarding Person are all required to complete the higher level leadership training in addition to the above.
- 3. Leaders of Sanctuary Space events are supported by a Trustee or Guardian who will ensure Leaders are aware of this statement and the support available within and external to

- Hopeweavers for those affected by domestic abuse and are confident to respond appropriately.
- 4. Similarly, leaders/co-ordinators of Hopeweavers Members' groups are supported by a Trustee or Guardian who will ensure they are informed and supported as in 3 above.
